COMPLAINT / AFFIDAVIT

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS

The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:

My belief of the foregoing statement is based upon:

I, Try Leadrs, being duly sworn, do state upon my oath that I have good reason to believe, I do believe, and I charge heretofore, that before the filing of this complaint, that Im A. Testcase, on or about the 2 day of January, 2008, in Pflugerville, Williamson County, Texas, did then knowingly and intentionally operate a motor vehicle while intoxicated upon a public roadway in the said County and State, to wit: 300 Block of Ave Q. At the time he/she operated the motor vehicle, the said driver did not have normal use of his/her mental or physical faculties as a result of the introduction of alcohol, a controlled substance, a drug, a dangerous drug, a combination of two or more of those substances, or any other substance into his/her body.

It is also presented to the court that at the time of this offense, the defendant had a prior final conviction for Driving While Intoxicated, namely: .

Probable cause for arrest was based on the following facts:

Defendant was observed driving at a high rate of speed on Ave Q. Using my radar, he was marked doing 50 miles per hour in a 30 zone. Defendant was also having difficulty maintaining traffic lanes.
